Fiduciary

The following roll forward issues are resolved:

- Federal. The CUSIP number rolls forward to the correct field on Income > Interest.
- Maryland. Local tax is now included in the prior year tax amount on Maryland > Underpayment Penalty Information > Exception B - prior year tax.
 - Our Update Pro Forma feature is now available for this issue, which allows you to choose to update your previously rolled forward fields. To do this, open your current year Maryland return and choose to roll forward the corrected prior year tax amount.
- Oklahoma. Prior year overpayment applied now sources from Form 513, Line 35, or Form 513NR, Line 39.
 - Our Update Pro Forma feature will be available for this issue with Release 2016-3.2, scheduled for Sunday, March 26, 2017.

Maryland local tax will be included in the prior year tax amount on Maryland > Underpayment Penalty Information > Exception B - prior year tax.

The Tax-exempt bond CUSIP number on the IRS-1099INT input will now roll forward to the appropriate field.

Oklahoma

Oklahoma Forms 513 and 513NR. Prior year overpayment applied will now roll forward to the Payments > Payments > Payments > Prior year overpayment applied field and will be coded to Oklahoma.
