Tax Updates

Corporation, Fiduciary, Individual Partnership, S Corporation

- **Minnesota.** New legislation has been passed to bring Minnesota into conformity with several federal tax provisions. Minnesota will be re-issuing forms and electronic filing specifications for impacted areas. We will update our software as this becomes available. Minnesota electronic filing is available for fiduciary returns; we are working with MN DOR to determine the treatment of previously filed returns.
- **Depreciation.** Pursuant to guidance issued by the IRS, AMT depreciation should equal regular depreciation even when the election to opt out of bonus depreciation has been made. We will update our default calculation on a future release, but for now the treatment can be selected on General > Depreciation and Depletion Options > Depreciation Options > Suppress AMT adjustment.

To make this change globally until the default is changed, enter one of the following codes in Configuration > Return Configuration Sets > Miscellaneous Options > Reserved for future use > Reserved for future use 3:

- ◆ 1 - Suppress AMT for current year assets
- ◆ 2 - Suppress AMT for prior year and current year assets

Partnership, S Corporation, Exempt Organization

Reports of Foreign Bank and Financial Accounts (FBAR) for Foreign Financial Accounts. After confirmation with FINCEN that all return types should adhere to the April 18, 2017, due date for accounts maintained during calendar year 2016, the due dates for Partnership, S Corporation, and Exempt Organization will be updated to align with all other return types.

The Credit for Increasing Research amount included on Form 1065, Schedule K, Line 15f, will not include the Payroll Tax Credit amount reported on Form 6765, Line 44, when the Payroll Tax Election is made.

North Carolina

Form D-403TC:

- Line 1 and Line now apply the amounts entered on North Carolina > Credits > Other Credits > Credit for Income producing Historic Structure and Credit for Income producing Historic Mill Facility.
- Line 2 and Line 4 now apply the amounts entered on North Carolina > Credits > Other Credits > Credit for Non-income producing Historic Mill Facility and Credit for Non-income producing Historic Structure.

Form NC K-1, Line 3A, statement for Deductions for Bonus Depreciation, will now show the adjustment for bonus depreciation added back for the previous five years.

Form 55, Page 3, Line 2, Column C, will no longer have an adjustment for rental income when Income/Deductions > Partnership Passthrough information is present.
