Individual (1040) Product Updates

Return to Table of Contents.

Federal

Form 8606. When there is a Form 8606 and IRA distributions that are entirely qualified charitable distributions (QCD), Form 1040, Line 15a, includes the QCD amounts.

Arizona

Arizona TEC, Line 20, tax due, no longer includes the amount of withholding.

Connecticut

Form OP-424 business name allows numbers.

Tax Equalization, Lines 22 and 26, are calculating the tax liability based on withholding and payments from the previous year.

Maine

Pension exclusion and standard deduction are excluded when dependent of another is claimed.

New Hampshire

New Hampshire late payment interest rate was updated to 6%.

Pennsylvania

Interest on U.S. Savings bonds and Treasury obligations carries to Schedule A, Line 7, when FS code is blank or F.

Massachusetts Electronic Filing

When only using the Credit Manager Schedule (CMS) Pages 3 and/or 4, the Company name, FEIN, and Total Credit Taken from Page 1 is now included in the electronic file.

Michigan Cities

The custom filing instructions for Form 5458 reflect the correct amount for prior year overpayment in the credits and payments section.

Rhode Island

Form RI-1065 now reflects the due date of the 15th day of the 4th month for Single Member LLC filers.

Tennessee

The extension financial record is no longer included in the electronic file when Federal > General > Direct Deposit/Electronic Funds Withdrawal coded for Tennessee is missing the direct debit/deposit check box and the confirm box is selected.

Corporation (1120) Product Updates

California Electronic Filing

Diagnostic 52617 was updated to indicate that payments and banking information are mandatory for electronically filed extensions.

Louisiana

Schedule D, Line 1D apportionment percentage, now defaults to 100% when no sales apportionment amounts are entered.

Rhode Island

Disqualifying diagnostic 44106 now issues if an invalid entry is present for state of incorporation.

The year end date now prints on RI-1120ES for calendar year returns.

S Corporation (1120S) Product Updates

Arizona

The calendar year boxes on Form 140ES are now checked when the composite return is a calendar year return.

The Form 140ES Nonresident Composite return payment check boxes are now automatically checked if a composite return is being filed.

Louisiana

Schedule D, Line 1D apportionment percentage, now defaults to 100% when no sales apportionment amounts are entered.

Oklahoma Electronic Filing

Form 512-S, Page 8, Schedule B and C percentages were updated in the electronic file to show as a decimal instead of percentage (50% is now .50).

Form IT 1041P now prints with the government copy of an electronically filed return.
