#### Minnesota

**Form M1PR.** Mailing sheets and letters now accommodate the four line address of Minnesota Property Tax Refund, Mail Station 0020, 600 Robert St. N., St. Paul, MN 55145-0020.

Minnesota will no longer include a current year NOL carryover on the carryover report to 2023. Minnesota now conforms to federal NOL carryover provisions starting in tax year 2022.

If the tax year beginning date is in calendar year 2022 and the tax year ending date is in calendar year 2023, use these 2023 forms to prepare BIRT and BIRT-EZ returns. If the tax year beginning date is in calendar year 2023, prepare the returns in the 2023 Tax program instead.

**Form 990, Schedule D, Parts VII and VIII Continuation Sheets** will now show EOY Market Value instead of FMV when End-of-year market value is selected on the Return Type > Form 990 - Exempt Organization Return > Balance Sheet Assets > Other Investments grid > Valuation Code column.
