Colorado. The 2015 sales tax refund is no longer included in the State Taxable Refund amount on Other Income > Refunds of State and Local Income Taxes (Interview Form M-3) for refund returns.

Fiduciary

- Arkansas. Nonresident returns no longer transfer 2015 tax due as a refund on Income Other Income > State Tax Refund section (Interview Form M-1).
- Colorado
 - Resident and nonresident returns no longer transfer 2015 tax due as a refund on Income Other Income > State Tax Refund section (Interview Form M-1).
 - The prior year taxes paid in the current year transfers to the Payments/Penalties Payments > State Estimated Payments > Prior year taxes paid in current year field (Interview Form CO6, Box 97).
