Information in Tax Year 2016 Release Notes

Office Manager

In Office Manager > Setup > Configure Staff > User we removed the Show Passwords buttons to increase security. This change will not interfere with the ability to reset users' passwords.

Extension Worksheet

Partnership, Corporation, S Corporation, and Exempt Organization

We have added the extension letter/filing instruction options to the Extension worksheet. This is in addition to the current location in Options and will allow users to quickly select and verify these options without navigating back to the Options worksheet.

Tax Updates

Individual, Partnership, Corporation, S Corporation, and Fiduciary

Minnesota updates are available related to new legislation passed to bring Minnesota into conformity with several federal tax provisions.

Electronic Filing Updates

Reminders Regarding New Electronic Filing Requirements for Tax Year 2016

Individual

Driver's license/state identification information will now be required for Ohio. ID entries or an affirmative selection of "No ID" will be required to electronically file. Additionally, a diagnostic will issue for Mississippi that the "No Identification" option for driver's license/state id should only be used if no identification exists. We will continue to update our logic as taxing authorities issue guidance for this area.

Partnership, Corporation, S Corporation, Fiduciary, and Exempt Organization

Officer ID - State requirements for electronic filing of most state returns now stipulate the inclusion of an ID for the return signing officer. This ID is the social security number for the signing officer. States also allow for the federal employer identification number as an ID for the signing officer, if applicable.

Number of W-2s - State requirements for electronically filing returns require the number of W-2s associated with any deduction for salaries and wages to be included for electronic filing purposes. All Fiduciary, Federal, California, Florida, Michigan, and Texas returns do not require this information and can be electronically filed without the number of W-2s present.

Notes:

- If these requirements are not met then your return will not qualify for export.
- The following states do not require the signing officer ID or the number of W-2s:
 - California
 - Florida
 - Michigan
 - Texas

FastForms is Now Active (Included with Release 2016.02020)

Last week we used our new FastForms feature to remove the watermarks from ten Nebraska pages.

We removed the watermarks from these forms when a user opened an Individual return. The forms are not replaced; they simply do not include the watermark. In order for this removal to take place, you must be on the latest release and you must be connected to the internet. If you do not meet these two conditions, the watermark will not be removed until the next release is installed OR until you connect to the internet.

Note: This process occurs for a tax product when you open a return.

This new feature allows us to release forms on a more frequent basis as we get taxing authority approvals for paper forms. Currently you have to wait until the next formal release for these updates. This will greatly improve your workflow and allow you to process paper returns more quickly, eliminating days from the process.

If paid preparer information is suppressed on Forms IT 1040 and SD 100, the "Authorize to contact" question will always be blank to allow electronically filing for self-prepared returns.

Tennessee

The extended due date for INC 250, requested by filing Form INC 251, is October 16, 2017.

The personal portion of rental expenses reported on Schedule M-1, Line 4a is now automatically reduced by state/city income taxes shown separately on the supporting statement for Schedule M-1, Line 4a.

Officers Compensation overrides for Cost of Goods Sold will now override when entries are made in the COGS 8916-A Section.

Oklahoma Electronic Filing

Form 512, Line 1. Diagnostic 42948 will no longer issue when taxable income is negative.

S Corporation (1120S) Product Updates

Schedule K-1 will now show on Print Preview in the Accountant's copy when an individual shareholder's K-1 transmittal letter is suppressed.

Hawaii

The Nonresident N-4 withholding rate changed from .11 to .0825.

North Carolina

Form CD-401S, Schedule C. Line 1, Total Assets will no longer include the deduction for accumulated depreciation, depletion, and amortization, as this is deducted on Line 5.

Ohio

Diagnostic 39774 will no longer issue when Form IT-4708 is not present in the return. This has been corrected on Release 2016.02030.

Estate and Gift (706/709) Product Updates

Federal

Form 706, Schedule M. Line 5a calculates correctly when the only property passing to the surviving spouse is nonresiduary property.

Exempt Organization (990) Product Updates

New Jersey

New Jersey letters and forms now reflect the mandated on-line filing requirement.

New York

Form TR-573-CT will only generate when Form CT-13 is present in the return and electronic filing has not been requested.
