Partnership

A new option is available to provide a blank copy of Forms 1065/1065-B when amending a return in order to file Form 8082, Notice of Inconsistent Treatment or Administrative Adjustment Request (AAR). You will also be able to specify which partners' Schedule K-1s need to be included with the return. This option is available and can be activated on the following forms:

- Form IRS-K1P, Box 811
- Form IRS-K1F, Box 561

Electronic Filing Status System

After performing a Filter/Search you will notice a change in the number of returns visible in the result set shown. We have greatly reduced the space between each row to maximize the number you can view before scrolling.



Note: Each page's display limit remains at forty rows, but you are able to see more rows before the need to scroll.

Individual (1040) Product Updates

Return to Table of Contents.

Pennsylvania

Form PA-40. Line 1a includes the correct amount from Schedule W2S, Part B when Form 8606 has taxable state amounts present in Column G.

Statement SBE. When it is present it will always be included with the printed copy of the Pennsylvania return.

Taxpayer or jointly filed PA-40ES vouchers display the correct primary SSN when the taxpayer is deceased on a jointly filed PA-40 return.

Tennessee

The Interest rate charged on INC 250 and FAE 170 balances is 8% beginning July 1, 2017.

Form 1065, Schedule K-1, Part II. Line 13 will no longer print a blank statement when the override is used.

Alaska

Arizona

When Federal Form 1120-C is filed, the return will calculate using the income and deduction amounts from Form 1120-C, Lines 25c through 27.

Indiana

When Federal Form 1120-C is filed, the return will calculate using the income and deduction amounts from Form 1120-C, Lines 25c through 27.

Massachusetts

Due dates have changed for 1120 returns with an original due date on or after 01/01/2018 to be 4 months and 15 days after the end of the tax year.

Mississippi

When Federal Form 1120-C is filed, the return will calculate using the income and deduction amounts from Form 1120-C, Lines 25c through 27.

Montana

When Federal Form 1120-C is filed, the return will calculate using the income and deduction amounts from Form 1120-C, Lines 25c through 27.

S Corporation (1120S) Product Updates
