Highlights for Release 2016.05020

Tax Updates

Tax year 2016 Hurricane Relief updates are being finalized now that the IRS issued final versions of revised forms. Federal and affected states are planned for 2016.05030, scheduled for January 14, 2018. The extended due date for those impacted by Hurricanes Harvey and Irma is January 31, 2018.

Those provisions of the Tax Cuts and Jobs Act that apply to TY 2016 fiscal filings, specifically bonus depreciation, are planned for Release 2016.05040, scheduled for January 21, 2018.

A new option is available to suppress driver's license information on Organizer. This option is available via Office Manager > Configure Office Group > Configure Tax Preparation > Miscellaneous Options > Reserved for future use 6.

California Combined

A new option has been added that will allow companies that are listed on Schedule R-7, Part II, Other Affiliated Corporations, to be included in the apportionment calculation. The new input is located on California (100 / 100W) > Combined Return > Other Information and Overrides > Line 26 (Interview Form CA-14, Box 65). The label for the new option is "X to include separate company in combined return but report on Sch R-7, Part II, Other Affiliated Corporations."

New Jersey
