- S Corporation Wisconsin Returns. Wisconsin Credits > Research Credits (Schedule R) > Carryover of unused research expense credit, Carryover of unused research facilities credit and carryover of super research and development credit (Interview Form WI23, Boxes 35, 51 and 68) will now correctly pro forma for S Corporation returns.
