Philadelphia. 2018 Forms BIRT and BIRT-EZ are available. We are awaiting approval for these forms from the city of Philadelphia.

S Corporation

Ohio. 2018 Forms IT 4708, IT 4708 ES, Universal Payment Coupon, and Form IT/SD 2210 fiscal year updates are available. We are awaiting approval for these forms from the state of Ohio.

Organizer

The question regarding total mortgage balances on Page 3 of the questions pages uses an amount of \$750,000 to reflect law changes contained in the Tax Cuts and Jobs Act. On releases prior to this release, Questions Page 3 can be customized to update the amount from \$1,000,000 to \$750,000 using the following steps:

- 1. From Production Processing, select Process Client Organizers > Create a Custom Letter > Individual.
- 2. When the Custom Forms Editor opens, choose File > New > Template and select Questions Page 3.
- 3. Make the desired changes, save the template, and exit the editor.
- 4. Return to Production Processing and choose Process Client Organizers > Customize Organizer > 2017 to 2018 > Individual (if not already selected) and click OK.
- 5. Select the custom form(s) that should be replaced within the organizer with the customized version. Select Edit and then choose Suppress Print.
- 6. Select Insert, choose the file name of the template created using the Custom Forms Editor, and enter a form description. Click OK.
- 7. If the custom form(s) created should replace an existing form in the Organizer, verify that printing for the existing form has been suppressed.
- 8. Click OK on the Customize Organizers dialog to save your changes and exit.

Vermont

When the election is made in Office Manager to allow the state to contact the preparer, it is reflected in the electronic file. Preparers will need to send a copy of the signed and authorized return if they need to discuss the return in question with the state.
