The Pre-2018 NOL deduction for Form N-70NP is limited to taxable income. The Post 2017-NOL deduction for Form N-70NP is limited to 80% of the taxable income remaining after applying the Pre-2018 NOL deduction. An NOL carryover amount is created when there is a current year loss for Form N-70NP.
