Tax Updates

Corporation

Federal. The IRS has mandated that Form 1120-POL, U.S. Income Tax Return for Certain Political Organizations, must be electronically filed for tax year 2023. For electronic filing purposes, the IRS considers this form part of the Exempt Organization umbrella. With that condition, we will be adding the Form 1120-POL and electronic filing to the Exempt Organization tax product with the plan to remove it from the Corporation tax product for tax year 2024. Electronic filing for this form will only be available under the Exempt Organization tax product for tax year 2023. The IRS will not begin accepting this form electronically until March 17, 2024. Please monitor Software News and Release Notes for availability.

Estate/Gift

Massachusetts. The state released an updated Form M-706, Massachusetts Estate Tax Return that is available in tax year 2022 and 2023. It includes the increased applicable exclusion amount of \$2,000,000 for those decedents dying in 2023 or after. Exempt Organization

Federal. The IRS has mandated that Form 1120-POL, U.S. Income Tax Return for Certain Political Organizations, must be electronically filed for tax year 2023. For electronic filing purposes, the IRS considers this form part of the Exempt Organization umbrella. With that condition, we will be adding the Form 1120-POL and electronic filing to the Exempt Organization tax product with the plan to remove it from the Corporation tax product for tax year 2024. Electronic filing for this form will only be available under the Exempt Organization tax product for tax year 2023. The IRS will not begin accepting this form electronically until March 17, 2024. Please monitor Software News and Release Notes for availability.

Massachusetts. With this release, the Annual Form PC has been removed from the software as all charities must now meet their annual filing requirements through the AGO's online charities filing portal. Please see the [state website](#) for more information on how to register, file and frequently asked questions about this process.

New Jersey. With this release, New Jersey is no longer active in the software as all charities must file on the state portal and no paper returns are accepted. Please see the [state website](#) for more information.

Electronic Filing Updates

The CCH Electronic Filing email and postcard notification system was updated earlier than release 2023.02000. We moved this change to release 2023.01000, available on December 3rd, to align with additional changes in the system.

All Entities

Kentucky Cities. Louisville has issued an [electronic filing mandate](#) effective January 1, 2024. Form OL-S, Generic License Fee Return, is available in the software to cover this mandate. The mandate also requires

the extension to be electronically filed. We will be adding this on a future release. Please monitor Software News and Release Notes for availability.

Corporation, S Corporation, & Partnership

Kansas City. Kansas City has issued an electronic filing mandate effective January 1, 2024, for Form RD-108, Profits Return Earnings Tax and Form RD-111, Extension - Profits Return Earnings Tax. We will be adding the ability to file the extension for the Corporation, S Corporation and Partnership tax products in a future release. The ability to file the Form 108 electronically was previously available in the system. Please monitor Software News and Release Notes for availability. Both forms are available to file electronically in the Individual tax product to comply with this mandate.

Corporation

North Carolina. The state is no longer accepting Form CD-405 CW, Combined Corporate Income Tax Worksheet, via electronic filing for tax year 2023. Any returns that need to be filed must be paper filed.

Exempt Organization

Federal Extensions. The IRS informed software providers that Form 8868, Application for Automatic Extension of Time to File an Exempt Organization Return, will not be available to electronically file until March 17, 2024. We plan on disqualifying the form until this date in the software.

Form 592-PTE (2023 version) and accompanying voucher, Form 592-Q (2023) is available. To process the 2023 Form 592-PTE, use California > Nonresident Withholding > Form 592 Other Information > Options to process 2023 Form 592/592-PTE (Interview Form CA21, Box 30 with Boxes 44 through 49). Either Form 592 or 592-PTE will produce based on the type of partners present in the return. To add additional payees or pass-through entities, use California > Nonresident Withholding > Form 592 Other Information > Schedule of Payees Information (Interview Form CA21, Boxes 80 through 135).

Federal

The input for Form 990, Schedule R has been updated. The Section 512(b)(13) Controlled Organization checkbox has been added to the Schedules > Sch R - Related Organizations and Unrelated Partnerships > Related Organizations Taxable as a Corporation or Trust. The sponsoring organization checkbox, which is used to verify the input of certain data, has been added to the following grids for the Schedule R: Identification of Related Tax-Exempt Organizations, Related Organizations Taxable as a Partnership, Related Organizations Taxable as a Corporation or Trust.

Massachusetts

Massachusetts Form PC has been deactivated and can no longer be used. Charitable organizations are required to file Form PC and pay any fees using the Attorney General's Charity Portal at <https://www.mass.gov/info-details/non-profit-organizationspublic-charities-forms>.

New Jersey

New Jersey Forms CRI-200, CRI-300R, and CRI-400. All forms have been deactivated and can no longer be used. Beginning 01/01/2017, online filing of ALL charity registrations and charity related reporting is mandatory.
