Tax Updates

All Entities

Form 5471, Information Return of U.S. Persons with Respect to Certain Foreign Corporations. Print collation has been addressed so that the schedules related to an entity print with the parent 5471. This will apply to all taxing entities.

Exempt Organization

Federal. Form 7004, Application for Automatic Extension of Time to File Certain Business Income Tax, Information and Other Returns, will be added to the Exempt Organization tax product. This can be used to file an extension for Form 1120-POL, U.S. Income Tax Return for Certain Political Organizations. The extension will be available to electronically file and we project having it ready for use by release 2023.02070, available by February 25th. Please monitor Software News and Release Notes for availability.

Individual

Washington. Washington has been added to the Individual tax product for tax year 2023. Form 40 2452, Capital Gains Tax Return, is available to be filed and will require the use of an authorization. WA in the home state field under General > Basic Data (Interview Form 1, Box 30) will neither generate the form nor request an authorization to be used. To generate this form, an entry can be made on Washington > General > X to force calculation of Washington return (Interview Form WA1, Box 44). If any entry on the Washington input forms is made, then an authorization will be requested to generate the state.

Electronic Filing Updates

All Entities

Electronic filing for tax year 2023 is available for the returns and extensions listed below for the specific tax products. For 990-T returns, the IRS is currently not accepting this form for any prior year or current year.

The Individual tax product is currently not available for electronic filing for tax year 2023. It is projected to be available on release 2023.02030. Please monitor Software News and Release Notes for which returns and extensions are available on that release. Prior year filings for tax year 2021 and 2022 are available for Form 114, California and Texas state only returns. Any other return for Individual, including amended, will need to wait until the IRS opens on January 29, 2024.
