# Welcome to CCH ProSystem fx Planning 2018.01000

This bulletin provides important information about the 2018.01000 release of CCH ProSystem fx Planning. Please review this bulletin carefully. #### Tax Cuts and Jobs Act

Legislation is currently being monitored and if passed, will be included on our 2018.02000 release made available February 4, 2018.

#### **New in this Release**

#### The ability to export a return from ProSystem fx Tax for a prior tax year

The ability to export prior tax year (2016) data from CCH ProSystem fx Tax is now available in addition to the ability to export from the current tax year (2017).

### Nonresident state tax calculation

Automatic calculation of nonresident state(s) tax is now available for certain states. To add a nonresident state to a plan:

- 1. Open an existing plan or create a new plan in CCH ProSystem fx Planning.
- Open Plan Properties in an existing plan by selecting File > Plan Properties, Ctrl + R, or by clicking the icon on the toolbar. Plan
  Properties opens automatically when creating a new plan.
- 3. Select the **Configuration** tab.
- 4. Click on the Nonresident State button.
- 5. Check the appropriate **Nonresident State** box.
- 6. Click OK.

The available states that calculate a nonresident tax return are:

#### Nonresident adjustments grid

This grid has been added to aid in the nonresident state tax calculation.

#### Credit for taxes paid to another state

The resident state credit for taxes paid to another state calculation and supporting worksheet is now available when an available nonresident state is selected in the plan.
