# **April Sales Tax Holidays**

## Missouri Show Me Green - April 19 - 25, 2023

Sales of qualifying Energy Star certified new appliances, up to \$1,500 per appliance, will be exempt from state and local sales and use taxes. If the amount is over \$1,500, the first \$1,500 is exempt from tax and the remaining amount over \$1,500 is taxable at the full rate.

The following are items that would be exempt from tax during the Show Me Green Sales Tax Holiday provided they are ENERGY STAR certified:

- Clothes Washers
- Clothes Dryers
- Water Heaters
- Dishwashers
- Air Conditioners
- Furnaces
- Refrigerators
- Freezers
- Heat Pumps

### Texas Emergency Preparation Supplies - April 22 - 24, 2023

These emergency preparation supplies qualify for tax exemption if purchased for a sales price:

- Less than \$3000
  - Portable generators.
- Less than \$300
  - Emergency ladders.
  - Hurricane shutters.
- Less than \$75
  - Axes.

- Batteries, single or multipack (AAA cell, AA cell, C cell, D cell, 6 volt or 9 volt).
- Can openers nonelectric.
- Carbon monoxide detectors.
- Coolers and ice chests for food storage nonelectric.
- Fire extinguishers.
- First aid kits.
- Fuel containers.
- Ground anchor systems and tie-down kits.
- Hatchets.
- Ice products reusable and artificial.
- Light sources portable self-powered (including battery operated).
  - Examples of items include: candles, flashlights and lanterns.
- Mobile telephone batteries and mobile telephone chargers.
- Radios portable self-powered (including battery operated) includes two-way and weather band radios.
- Smoke detectors.
- Tarps and other plastic sheeting.
