January Sales Tax Holidays

Florida Back to School - January 1 - 14, 2024

During the sales tax holiday period, tax is not due on the retail sale of:

- Clothing, footwear, and certain accessories with a sales price of \$100 or less per item
- Certain school supplies with a sales price of \$50 or less per item,
- Learning aids and jigsaw puzzles with a sales price of \$30 or less
- Personal computers and certain computer-related accessories with a sales price of \$1,500 or less, when purchased for noncommercial home or personal use

Puerto Rico Back to School - January 4 - 5, 2024

School uniforms and specified school supplies will be exempt.

Updates and Changes

Georgia Digital Downloads

Tax will apply to in-state sales of digitally-downloaded products including books, magazines, newspapers, video games or electronic entertainment, music, artwork, photographs and video or audio greeting cards.

Kansas Food Rate Reduced to 2%

The 4% state rate on eligible food is being reduced to 2% effective January 1, 2024, and is scheduled to be eliminated on January 1, 2025. Local taxes continue to apply at the regular rate. Eligible food includes candy, soft drinks, dietary supplements, and certain prepared foods sold without utensils, such as baked goods and unheated foods mixed or combined by the retailer and sold by weight or volume as a single item.

Loveland, Colorado, No Longer Taxing Food

Loveland repealed its sales tax on food for home consumption.

Milwaukee, Wisconsin, City Tax

Wisconsin's first city sales and use tax is being imposed in Milwaukee.

New Jersey Social Equity Excise Fee Reduced

The Social Equity Excise Fee is reduced from \$1.52 to \$1.24 per ounce of recreational cannabis.

Office Services Group Expansion - Credit Card Surcharge

Item 008, credit card surcharge, has been added to group 6015, office services.
