Deployment Information

2023.2.1 Provided on Software Delivery Manager

This Workpaper Manager 2023.2.1 release is only available through Software Delivery Manager and uses an MSI for upgrading your workstations. It will not be available to download directly from our Support site.

The following firms should install this 2023.2.1 release on all servers and workstations:

- Your firm has not previously installed a release of Workpaper Manager.
- Your firm is upgrading from a 2021, 2022, or prior 2023 release of Workpaper Manager to work with all features and resolved issues.

Note: For firms with an earlier version of 2023 already installed, there is no database upgrade when deploying this latest release. This allows for workstations to be upgraded separately from the server. A firm can work in a mixed environment if all machines have any 2023 release installed. We do, however, highly recommend that all workstations are updated with this release.
