ProSystem fx Portal

Enhancements:

Optional Simplified Portal interface (not requiring Microsoft Silverlight) is now available.

- ProSystem fx Portal now features an optional, limited functionality, simplified login interface alternative for users that experience challenges installing Microsoft Silverlight. The simplified portal login option provides basic upload and download capabilities. For functionality beyond upload and download, users will need to install Silverlight and login using the Standard Full-featured interface.

- Users that navigate to ProSystem fx Portal without Silverlight installed will receive a message to install Silverlight with an

Using the portal is preferred over e-mail for securely sending your confidential financial documents and tax returns. Attached to this e-mail is a Portal User Guide which will teach you how to manage your portal. If appropriate, you can create additional portal users and assign security for those users.

If this is your first Portal, you will receive two additional e-mails: one e-mail will include your user name and log-in instructions; the other will provide you with a temporary password to log into the portal the first time.
