ProSystem fx Portal

New Folder Level Permissions - You can now grant and deny users or clients access to specific folders within their portal.

New "Getting Started" Wizard - Your clients and users now have an interactive Welcome message and step-by-step help wizard to walk them through basic portal functionality, which includes:

- Welcome Message
- Creating a Portal
- Creating a Firm User
- Adding Files
- Creating a Portal User

Email Notification Enhancements - Email notifications provide important new information to Portal users.

- The new email notification, "File downloaded by portal user", allows selected parties to receive notifications when a portal user has downloaded a file.
- The ability to attach Portal User Guides to Portal creation notifications allows firms to add a firm-branded client-facing Portal User Guide to "Portal Creation" notifications and "Portal User Created Welcome Email" notifications.
- An email notification enhancement adds the ability to add one or multiple firm-side Portal approvers to a client's Portal.
- An "Email to" option allows you to specify Portal approvers as notification recipients.
