- Overrides for the asset description for Form 8971 purposes
- Overrides for the percent/amount of an asset that carries to Form 8971

## **Tax Product Updates**

### Estate & Gift (706/709) Product Updates

#### **Federal**

An option is available to not carry property data from the Gross Estate worksheets to Form 8971.

For each asset, an option is available to override the beneficiary's percent or amount that carries to Form 8971. Use this option to include the property that could be used to fund the beneficiary's distribution on that beneficiary's Schedule A.

For each asset, an option is available to override the description that carries to Form 8971.

When *Do not include on Form 8971* is selected for a Form 706, Schedule E, Part 2 asset, the asset does not carry to Form 8971.
