2016 Tax Updates

Corporation Extension Due Date

The Corporation extension due date for calendar year 2016 returns is September 15, 2017. An earlier CCH Software News stated the due date as October 15.

Corporation and S Corporation

The Update Pro Forma Feature is available to resolve an issue with Electronic Filing > Electronic Signature Roll forward when the option to "Clear electronic filing overrides" is selected in the return configuration set.

The following fields were being dropped in Roll Forward and will now be included in the 2016 return, if you accept the change upon opening any affected return:

- Taxpayer self-selected PIN
- PIN authorization indicator
- Signing officer's name

Partnership, S Corporation, Exempt Organization

Reports of Foreign Bank and Financial Accounts (FBAR) for Foreign Financial Accounts. After confirmation with FINCEN that all return types should adhere to the April 18, 2017 due date for accounts maintained during calendar year 2016, the due dates for Partnership, S Corporation, and Exempt Organization will be updated to align with all other return types on Release 2016-2.2.

Partnership, Corporation, S Corporation, Fiduciary

Form 7004, Application for Automatic Extension of Time to File Certain Business Income Tax, Information and Other Returns, is a preliminary draft for this release. The Internal Revenue Service has not yet released a final draft of the form. For electronically filed returns, you will not be able to export Form 7004. Beginning with Release 2016-2.2, if the final draft is not available, Form 7004 will be available for electronic filing, in spite of its preliminary status.

- Officer ID. State requirements for electronic filing of most state returns now stipulate the inclusion of an ID for the return signing officer. This ID is the social security number for the signing officer. States also allow for the federal employer identification number as an ID for the signing officer, if applicable.
- Number of W-2's. Federal and state requirements for electronically filing returns require the number of W-2's associated with any deduction for salaries and wages to be included for electronic filing purposes.

The return due date for calendar year insurance companies filing Forms 1120-PC / 1120-L has been updated to April 18, 2017, in accordance with Internal Revenue Code 6072.

S Corporation (1120S) Product Updates

California

Form 588, 2017 Nonresident Withholding Waiver Request, is now available for filing. Nonresident payees who qualify can use Form 588 to get a waiver from seven (7) percent withholding based generally on the shareholder's California tax filing history, such as filing a group nonresident return. The S Corporation keeps a copy of the determination letter for their records. The S Corporation must submit the completed form at least 21 business days before the payment to allow the California Franchise Tax Board time to process the request. The year of the form must match the payment date of distributions to shareholders.

CIFT-620, Schedule E, Line 7, and Schedule F, Line 3b, now include federal-only interest.
