# Tax Product Updates

### Partnership (1065) Product Updates

Return to Table of Contents.

#### Federal

Form 1065, Schedule K, Line 18c, has been updated to exclude the nondeductible 50% meals and entertainment expenses from rental properties that have the code S (State only code) entered in the FS field in Income/Deductions > Rent and Royalty worksheet > General.

The Partners' Schedules K-1 mailing sheets will get printed before the Partners' K-1 transmittal letters in the K-1 copy.

#### Connecticut

CT-1065/CT-1120SI, Line A, return type explanation for final return, will now produce.

#### Kentucky

The federal depreciation detail will no longer print.

#### **New York**

New York Form TR-579-PT will no longer print ERO or Paid preparer's date when the option to print the date signed by preparer/ERO has not been selected in the return configuration set.

Options have been added to New York > General Information > Printing Options > Suppress partners IT-204IP and Suppress partners IT-204-CP to allow multiple entity types to be suppressed.

The preparer name will now print on Forms IT-204, IT-370-PF, and IT-204-LL when the preparer name is entered in the return configuration set or General > Return Options > Preparer Information - Overrides Officer Manager > Preparer name when the Print preparer signature is "No."

#### New York Electronic Filing

Form IT-204-LL will now be transmitted to New York if there is a "&" in the legal name and upper case selected in either the return configuration set Print Options > Print in upper case only or General > Return Options > Processing Options > Upper case.

#### Ohio

The current year depreciation deduction for the 2012 addback entered on the Ohio IT 1140 Passthrough Entity Tax Return > General Depreciation > General Depreciation Adjustment Information section > 5th Prior Year Add-back now calculates correctly.

#### Oregon

Forms OR-TM and OR-LTD. When self-employment earnings are overridden, the partner information statement will now reflect the appropriate amounts. A diagnostic will issue if there is a discrepancy between the total on the form and the total on the statement due to the overrides.

#### Texas

The option for Electronic Funds Transfer will now display the option description.

#### Oklahoma

Form 512-S, Oklahoma Small Business Corporation Income and Franchise Tax Return, Page 8, registered agent's address, now properly exports and is included in the electronic file with an entry on Oklahoma > Franchise Tax > 2. Franchise Tax Return Schedules B, C, and D > Registered agent address.

## Fiduciary (1041) Product Updates

#### Federal

Schedule D. AMT Schedule D, Line 19 statement reference, no longer prints. The "Unrecaptured Section 1250 Gain Worksheet" prints instead of the statement, when applicable.

#### California Electronic Filing

Diagnostics 44596, 44923, 44929, 46804, and 46805 will not issue if the beneficiary's entity type is entered as a Trust and the Estate/Trust box will be selected on the CA 541 K-1.

#### Kansas

The trust EIN will now print on Form K-18.
