New York City released a new schema; the updates included with this release will be required to file Form 1127 returns.

Michigan

The preparer's PTIN or SSN now prints in the preparer information section of the signature block on Form MI-1040 and 1040-CR-2.

New Hampshire

When the printing of Form BET has been suppressed through input, Form BT-Summary will now mark the "not required to file BET" box.

New Hampshire Electronic Filing

New Hampshire disqualifying diagnostic 47149 will issue when Form BET-80, Line 10 does not equal either 2.0 or Line 3 + Line 6 + Line 9.

New York

Prior to Release 2019-3.5, Form TR-579-IT reported the New York column for "Federal AGI" on Line 1. After consulting with the NY DTF, this line has been changed to reflect the federal column for "Federal AGI."

The Electronic Filing Status System can be used to identify returns "in flight" to taxpayers where the return is recalculated on or after 2019-3.5, thus changing the signature document. Add the Calc Version column to the Release Return tab, then sort on the Calc Version column to find returns calculated prior to 2019-3.5 that have not been transmitted.

Rhode Island

The due date of the second estimated tax payment has been extended from June 15, 2020 to July 15, 2020.

Vermont

Document ID has been added to the electronic file to support PDF attachment to the State of Vermont and prevent schema validation errors.

Vermont Form IN-112, Line 10 Medical expense deduction worksheet will include the amount from Vermont Form IN-111, Line 6 in the electronic file.

Wisconsin

The due date of the second voucher for paper filed estimates is July 15, 2020.
