Tax Updates

All Systems - Consolidated Appropriations Act

Software changes are ongoing and will be available on future releases.

Individual and Fiduciary - Organizers

The Individual Organizer Questions Page 5 of 5 now includes a section for Payroll Protection Program loans. The Fiduciary Organizer Questions Page 2 of 2 now includes a section for Payroll Protection Program loans.

Corporation

"Roll forward failed" message is no longer encountered when Indiana or Rhode Island is present in the 2019 tax return.

Partnership

Roll forward of Schedule K-1 additional partner information for disregarded entities is corrected to attach to the correct partner when the sort partners on next year's pro forma option is selected in the 2019 tax return.

Electronic Filing Updates

New VCN Numbers for Business and Fiduciary Electronic Filing

The IRS has extended the use of Vendor Control Numbers (VCNs) to business and fiduciary electronic filing. Existing Tax customers who already have an established VCN have no action. New Tax customers or customers who have not filed individual returns electronically who have submitted their eServices EFIN application should follow the knowledge base articles below. They will be provided a VCN before electronic filing opens in January 2021.

Any eServices EFIN applications submitted after January will be processed and a VCN provided within 48 hours.

Once issued, you may locate your VCN within the Electronic Filing Status System by selecting Admin, located to the right of your name, then Vendor Control Numbers. You must then enter your VCN in the Electronic Filing Options > General window in the Return Configuration Set. More information is available in our Knowledge Base.

Electronic Filing Schema - Fiduciary and Individual

A production schema is now available for Fiduciary returns. Fiduciary electronic filing will be available on January 17, 2021. The IRS has not provided an Individual production schema or open date for Individual returns, so no current timeline is available.
