Louisiana

Resident Schedule E, Line 5B includes work opportunity credit when originating from a passthrough entity.

The Nonresident and Part-Year Resident (NPR) worksheet, Line 18a picks up the IRC 280C expense from passthrough entities with Louisiana source income. If Louisiana is not the primary state on the passthrough, and Louisiana is not the home state, the State Percent must be entered.

North Dakota

Amended North Dakota interest and penalties are requested starting with Federal > Payments/Penalties/Estimates > State Penalties and Interest section and entering Amended interest and penalties overrides on North Dakota > Other > Amended section to allow ND-1, Lines 34AK and 34AL to calculate in an amended return.

Rhode Island

All states are listed on the printed version of Form RI-1040NRMU. The electronic version previously reported all states.

Virginia

Forms 760C / 760F calculate penalties as of June 1, 2021.

An amount entered on General > Depreciation/Depletion Options and Overrides > Section 179 carryover from passthrough entity field no longer generates incorrect depreciation for state Section 179 assets.

New York

From CT-3.4, Schedule A, Column C completely reports the source years of losses applied in the current year for the combined level.

New York - New York City

Form CT-3-A/BC, Member Detail Report, and Form NYC2.5A/BC, Member's Computation of Receipts Factor, "Yes" check boxes concerning the election to use the 8% fixed percentage method for qualified financial instruments (QFIs) will now carry from separate company level input; government view overrides remain available.

Oregon

When exporting a Consolidated OR-CAT return, separate member returns are now exported at the same time.
