#### Form 7203

- Diagnostic 29278, indicating that Form 7203 is a work in progress, has been removed.
- Diagnostic 29340 will issue to inform the user that the alternative minimum tax (AMT) version of the form continues to be a work in progress.

**Form 8933.** The IRS requires model certificates to be attached to this form when there is an amount on Lines 1a, 2a, 3a, 4a, 5a, 6a, 9, or 12. These certificates are available in the 2021 Form 8933 instructions. They are added as optional PDF attachments on General > Electronic Filing > PDF Attachments using PDF codes 45 - 49. Lines 1a and 4a use code 45, Lines 2a and 5a use code 46, Lines 3a and 6a use code 47, Line 9 uses code 48, and Line 12 uses code 49. If the correct certificate is not attached, the return will be disqualified for electronic filing and Diagnostic 61066 will issue.

**Two Year Comparison.** Diagnostic 29338, indicating that Two Year Comparison is a work in progress, has been removed.
