Individual (1040) Product Updates

Return to Table of Contents.

Federal

Form 8865, Sch K-3, Page 4, Line 24 total will calculate when data is directly keyed in on Pages 1 through 4.

Non-passive business, rental, or farm with passive carryovers and current year 4797 loss no longer applies the current year loss to the passive carryovers for the qualified business income deduction.

Alabama

Alabama refund telephone number has been updated in the filing instructions.

Arizona

Form 309 SBI is available. If credit for taxes paid is claimed on the SBI return, Form 309 SBI must be prepared as well.

California

3805V AMT Part II, Line 1 and Part III, Line 2 and/or 3, Column F now calculate along with the deduction from Schedule CA, Part I, Section B and Schedule CA (540NR), Part II, Section B, Line 9b1 and/or Line 9b2.

Schedule CA, Part I, Section B and Schedule CA (540NR), Part II, Section B, Line 9b1 and 9b2 now reflect the amount used on Form 3805V, Part III, Line 2 and/or 3, Column f. Diagnostic 29343 no longer issues.

Colorado

State sales tax credits no longer calculate after April 18, 2022 for returns with no state income tax liability and no state withholding.

Indiana

Form IT-40X is obsolete and has been removed from the program as it is not a valid government form anymore. If you need to amend (correct) your 2021 individual income tax return after you initially filed, prepare another IT-40 return that reflects all changes and check the "Amended" box on the front page. This applies to the resident and part-year resident forms as well. All amounts previously paid should be reported as an estimated payment. All refunds previously received should not be reported on an amended filing. Amended e-file is not supported at this time.

Iowa

2019 60% charitable contributions carryovers are now included in the charitable contributions worksheet.

The carryover report now includes the computed NOL amount when there is also an NOL carryforward on Part I.

Maryland

MD 502CR Part CC, Line 10 will include any amount reported on Part CC, Line 9.

Minnesota M1PR

Form M1PR, Line 5 will not include contributions from 1099R, Line 5.

Missouri

The late payment interest rate has been changed from five percent to three percent.

Montana Electronic Filing

Returns with a 1099-MISC with a payer that has a comma within the first 5 characters of the payer's name will no longer receive a schema error when electronically filing Montana returns.

New Jersey

NJ-1040, Line 42 now calculates if Line 29 is above the filing threshold for part-year resident returns.

Oregon - Multnomah/Portland/TriMet

Form ARTS is now available to be electronically filed.

The preparer name and phone number fields on Forms MET-40, MC-40, MET-40-NP, and MC-40-NP now pull directly from RCS if there is data present.

The standard filing instructions for Form SP-2021 now include the proper information.

Virginia

Form 763S. "If your state of residency for tax purposes does not have an income tax, check here" and "Did you file a state income tax return for the year in question with the state reported under question 4 above" operate independently of one another.

Form 8865, Sch K-3, Page 7, Part 3, Section 2, Line 2b will only populate based on input.

Missouri

Forms MO-1120S, MO-7004, MO-1NR, MO-2NR, INT-2, INT-3, and MO-60 now allow a foreign company address.

MO-NRS will now calculate when using Allocation of Nonapportionable Income on MO-MSS.

Oregon - Multnomah/Portland

Form SC-2021. Underpayment Penalty rate was updated to the correct rate.

Partnership (1065) Product Updates

Federal

Form 8865, Schedule K-2. Foreign tax paid input will flow to Form 8865, Schedule K, Line 21.

Form 8865, Schedule K-2, Page 5. Net Income calculation on Line 55 will now include income from Page 3, Line 24.

Form 8865, Schedule K-2, Section A, Line 1 will now be checked when any Part 1, Boxes 2 through 12 are checked below on Page 1. Form 8865, Schedule K, Box 16 will be automatically checked when 8865, Schedule K-2 is present.

Idaho

The amount of Idaho income tax on Form 41S, Line 44, or Form 65, Line 42, can no longer be negative when making the affected business entity election.

Kansas

Form K-59, Line 13 now utilizes the input on Kansas > K-59 > General Information > Amount of credit received by transfer.

Michigan - Michigan Cities

Salaries and wages after employment credit will be reported on Form 5458, Page 3, Line 17

Oklahoma

2018 Form 506 in Column (10) will now include the amount of credit utilized in 2021.

Fiduciary (1041) Product Updates

Form 8995/8995-A and Schedule K-1 Statements. If there are any distributions in the return, the SSTB QBI income/loss and carryovers are now distributed by the same percent even when the return's income is above the threshold.

ESBT. The ESBT charitable contribution worksheets now pull the entity name and identification number correctly.

ESBT NOL AMT calculates amounts for Line 1 based on the ESBT loss amount instead of regular tax loss amount.

Partial Grantor. The state tax refund year on the statements and footnotes will now show 2020 when appropriate.

Hawaii

Schedule D, Pages 1 and 2 no longer print when the return type selected is a Custodial Remainder Trust.

Massachusetts

Distributed ELTCRD credits on Schedule CMS, Section 3 now show in Column H, while the trust portion shows in Column G.

Letters produce for Form 63D-ELT when all of the refund is applied to the estimates.

Vermont

Penalty and interest now calculate from the original due date when an extension payment override has been entered for the federal return.

Form 8995, Line 6 will no longer double when multiple activities are used on passthrough input.

California

Form RRF-1 has been updated to calculate the minimum fee when gross revenue is less than \$0.
