Minnesota

The Minnesota software has been updated for the 2023 Federal Conformity updates. Minnesota tax laws now recognize the Internal Revenue Code as amended through December 15, 2022. These updates may impact state income tax returns filed with a nonconformity schedule for tax years 2017-2022. Taxpayers may need to amend their returns to correctly determine their Minnesota taxable income for the affected years.

Federal

Schedule K-1. If you are generating the Section 163(j) statement for the Schedule K-1, depreciation will no longer addback to the Adjusted Taxable Income calculation as per the new Form 8990.

Idaho

Form 41ESR will no longer print when electing to file an ABE return since estimated tax payments are not required.

Kentucky

Form PTE, Page 2, Line 13 statement no longer generates when the amount is overridden, and no longer contains an empty entry for rental depreciation.

Federal

Schedule K-1, IRC Section 163(j) adjustment statement will no longer include the Depreciation, Amortization, and Section 179 amounts.

The codes to include or exclude the following are changing when a return gets rolled forward from 2021 to 2022:

- Section 743(b) adjustments
- Section 754 adjustments
- Guaranteed payments for services and capital from Schedule K-1 and Schedule M-2

These changes appear on Partners > General Options > Schedule K-1 Calculation Options > Boxes 25 and 26.

Kentucky

100% meals deductions taken on Federal are no longer added back at 50%.
