Individual (1040) Product Updates

Return to Table of Contents.

Federal

Form 4797. An issue for states that do not conform to bonus depreciation surrounding Form 4797, Part II has been resolved. The issue primarily affected Wisconsin 1040 returns and caused the other gains amount on the main form not to match the Wisconsin Form 4797.

Form 8865, Schedule K-3, Page 6, Part 3, Section 1 no longer duplicates and is now reported to the relevant partner.

Tax Projector. Increasing or decreasing the number of dependents will affect the projected child tax credit from Schedule 8812.

California

Form 3804-CR, Line 4 is updated when Schedule P (540NR) or other credits are present, and the exclusion override option indicating that the gross receipts are greater than \$1,000,000 is selected on the Schedule P AMT.

Electronic Filing

Form 1040X.

- Update made to issue electronic filing diagnostic 61512 in order to prevent IRS reject 1040X-037
- Update made to prevent electronic filing diagnostic 47636 from being issued on Form 1040X when filing status is MFS on original and amended return.

Hawaii

Amount entered on Hawaii > Estimates / Underpayments > Payments > Withholding on Form N-288A from a passthrough entity will now be included in payments and credits on the Hawaii transmittal letter.

Kansas

The Kansas Department of Revenue phone number listed in transmittals and letters is now (785) 368-8222.

Mississippi

Tax Return Filing Instructions and Return Summary no longer include Consumer Use Tax or Catastrophe Savings Tax in the Tax amount. Consumer Use Tax will be reported as Sales and Use Tax while Catastrophe Savings Tax will be reported as Other Taxes on the Return Summary. Taxpayer and Spouse tax bracket percentages have also been updated to reflect the current tax rates.

lowa

Form IA 1120, Page 4, Schedule C1, Line 2 includes the correct amount for credit on Form 148.

Maine

Schedule NOL limits net operating loss deductions taken.

Mississippi

The website for the EFT paragraph in the transmittals and letters has been updated to "www.dor.ms.gov."

Wisconsin

Form 6BL, Line 30, Column i decreases by amount in Column h if the expired amount is present.

Form 7203.

- Line 46, Column D calculates correctly as it will reference the correct Column C value in its calculation.
- Print positions have been updated on the Form 7203 overflow if you have a shareholder with 4 or more loans.

Arkansas

Footnotes for an AR1100PET return are only produced for AR coded footnotes.

Schedule AR-AIS will no longer show rental loss as a negative.

Colorado

Form DR0106, Line 5 will include charitable contributions from Form 1120S, Page 3, Line 12.

Iowa

Form 1040C, Line 7 calculates correctly for the \$26,145 - \$34,860 tax bracket.

Kentucky

Form PTET-CR will no longer print both the NR withholding number and the LLET account number in the same spot when both are entered in the return.

Letters are updated when gross receipts are over \$1,000,000.

The cover letter will no longer reference Form 740-PTET extension when it is not active in the return.

Louisiana Electronic Filing

The "Timely requested extension for federal income tax purposes" checkbox on Form CIFT-620 is now included in the electronic file.

Maryland

Form 511, Line 13a has been updated to no longer included the duplicate overpayment amount.

Missouri

Axcess letters and filing instructions for Missouri Form MO-PTE will include payments made.

North Carolina

Schedule K-1.

- Schedule K-1, Line 10 and Schedule K, Line 15, Share of North Carolina Taxable Income calculate income allocated for residents and nonresidents.
- Schedule K-1, Line 10 calculates based on Lines 16, 17, and 18 when a Taxed S Corporation election is made.

The overpayment field in transmittal letters correctly prints amounts from NC CD-401S, Page 2, Line 31.

West Virginia

The amount paid toward next year estimates entered on Payments/Penalties/Estimates > Estimates and Application of Overpayment > State Estimates and Application of Overpayment > Detail for State Code OHS > Line 28 - Amount paid toward next year estimate is now included in the estimated tax filing instructions.

West Virginia

Schedule EK-1 is now available. To generate this form, use input on Common State/City > State PTE Generation > State PTE Return Generation > Generate state PTE return - West Virginia . The amounts from the regular Schedule K-1 will flow to the Schedule EK-1 by default. To override these amounts use, West Virginia > Taxes > General Information > Form EK-1 Overrides. Corporate and exempt partners are excluded from Schedule EK-1.

Partnership (1065) Product Updates

Federal

Form 8865 Schedule K-2, Part II, Line 49 flows when using the 8865 automatic calculation. When that is the only item in Part II, all pages of 8865 Schedule K-2, Part II generate.

Form 8997, Columns E and F can go by the term code entered on Income/Deductions > Sch D/4797/4684 - Gains and Losses > Term column.

California

Section 743b adjustments will be included in the California Schedule K-1 "Other Deductions" but will not be included in the California Schedule K-1 Capital Account, Other Increases and Decreases.

Illinois

IL Schedule B, Line K is calculated to be each member's share of the partnership's own PTE tax credit.

Kentucky

Form PTET-CR populates when appropriate if partner's Federal Schedule K-1 shows no income.

Kentucky Electronic Filing

Form 8879(C)-K has been updated to contain 740NP-WH information. The letters have been updated to reflect this.

Mississippi

The diagnostic 43317 has been removed as Mississippi allows electronically filed amended partnership returns.

North Carolina

The Direct Deposit report will not generate an entry for extensions if the extension is not being electronically filed.

Form NC-40 PTE includes resident partners on Line 7.

Schedule TC Part 5, Line 21 equals Line 20 divided by Line 19 rounded to 4 decimal places.

West Virginia

Schedule EK-1 is now available. To generate this form, use input on Common State/City > State PTE Generation > State PTE Return Generation > Generate state PTE return - West Virginia. The amounts from the regular Schedule K-1 will flow to the Schedule EK-1 by default. To override these amounts use, West Virginia > Composite > Form NRW-4 > Form EK-1 Overrides. Corporate and exempt partners are excluded from Schedule EK-1.

Fiduciary (1041) Product Updates

Federal

Form 5471. Inputs have been updated to allow for multiple entries for the 5471 Schedule B, Schedule G-1, Schedule I, Schedule J, and Schedule M.

Form 8865. Disqualifying diagnostic 60175 only issues when the 1065 version that is present behind Form 8865 is not supported for e-file.

Idaho Electronic Filing

Form 8879-SO prints with Idaho when appropriate.

Exempt Organization (990) Product Updates

Federal

A new Efile report has been added and will show the forms and schedules being filed with either the 990, 990EZ, 990-PF, or the 990-T at the time of export. This new report can be viewed under Federal > Efile Info > Forms included in the electronic file.

Florida

The estimate tax rate has been updated to 5.5% instead of 4.458%.

Massachusetts

Effective September 1, 2023, charitable organizations are required to file Form PC and pay any fees using the Massachusetts Attorney General's Charity Portal. A diagnostic has been added and the letters and filing instructions have been updated to reflect this requirement. A modification has also been made to allow Form PC to produce without a Form 990, 990EZ, or 990PF in the return if the form has been forced on the Massachusetts > Form PC > Form PC General Information > Form PC preparation option field.

Oregon

Forms CT-12, CT-12F, and CT-12S now print in the government copy when electronic filing is selected. A copy of federal forms will also be printed.
