Washington. If a state authorization is being requested on a return where you have not requested Form 40 2452 Capital Gains Tax Return to be generated, please follow these steps:

1. Open Return.
2. Open General > Basic Data.
3. Right Click and select Delete > Delete State.
4. Highlight “WA” and select “OK.”
5. On the screen that asks, “Are you sure you want to delete WA?” select “Yes.”
6. On the screen that says, “Deleted Unit WA” hit “OK.”
7. Recalculate the return. No state authorization should be requested.

Iowa Form 1120F, Schedule A, Line 2 calculates the correct amount when information to indicate a financial institution for Schedule A is present. Overrides are available in Iowa > Other Returns > Financial Return > Schedule A - Additions Line 16.

Kansas

When a foreign address is entered for the return, it displays on all relevant forms and vouchers.

New York

Refunds resulting from the overpayment of PTE taxes are automatically reported on Form CT-225, New York State Modifications.

Schedule K-1, Line 10. Allocations of passthrough amounts with activity numbers present will properly pull the Section 1231 amount when an amount is also present under Section 199 and is being specially allocated.

Alabama

Form PTE-CK1, Column E equals the total of Schedule K-1, Lines G, H, I, J, K, L, and M. This can be adjusted using Alabama > Composite Return > Nonresident Composite Payment Return > Alabama source income - override.
