Tax Updates

Individual

West Virginia. Input is now available to allow electronic filing when claiming one of the credits on Line 21 of the WV IT-140.

- For Motor Vehicle Property Tax (21A) Input must be made on West Virginia > Credits > Other Credits > Motor Vehicle Property Tax Adjustment Credit.
- For Disabled Veteran Real Property Tax (21B) or Small Business Property Tax (21C) A PDF code of WV50 and WV51 has been added on Federal > Electronic Filing > PDF Attachments to attach a PDF when claiming these credits.

Gift Tax

Federal. Input has been added under Federal > Gift Tax > Gifts > Description of Gift or ETIP > Description of Gift to fill Schedule A, Column d. This will flow to a statement behind the schedule due to the size limitation of the column and is limited to 59 characters. Data entered in the previous description of gift (Federal > Gift Tax > Gifts > Description of Gift or ETIP) has not been removed and will still flow to Schedule A, Column b. To remove the "Description of Gift" from Column b, the data in Federal > Gift Tax > Gifts > Description of Gift or ETIP must be deleted.

The donee's relationship will flow to the statement behind the Schedule A due to column width on the form instead of Column b.

Colorado. The state has not provided an opening date for filing for any product. We are monitoring closely.

Corporation & S Corporation

Michigan. If banking information was included in a Tax Year 2024 Michigan CIT return, the state will not process the payment as expected. If a balance due needs to be paid, please use one of the options below to complete the necessary payment by the due date:

- Electronic funds Transfer (EFT). Make the necessary payment on the Treasury's website.
- Paper Payment Voucher. If you choose to mail your payment, please include Form CIT-V. This voucher can be printed from the MI website.
- Michigan Treasury Online (MTO). Taxpayers may access their account on MTO and initiate a Free EFT debit or a credit/debit card payment. A transaction fee may apply for credit/debit card payments.

Once Michigan goes live with the banking draft within the electronic file, the diagnostic will be removed. Please monitor Software News/Release Notes for updates.

Alabama

Form 65, Schedule A, Line 4 contains the Alabama state and city taxes entered on Federal > Income/Deductions > Business > Taxes and Licenses. To override Line 4, use the input on Alabama > Income / Deductions > Income > State income taxes not deducted — override.

Arizona

Form 220/PTE, Line 6e is the minimum of Line 6a or 6d.

Delaware

Masking has been added for all Delaware forms to mask SSN and EIN.

Georgia

Form IT-CR form code 4 has been set to inactive. Form code 3 now calculates to the tax rate instead of tiered.

Idaho

Schedule K-1, Line 60 is calculating correctly when Form 44, Line 1 is filled and the return is being filed as an ABE.

Indiana

IN PTET Estimates produce four vouchers instead of one voucher.

Schedule Composite no longer prints when there are zero partners listed on the form.

Michigan – Michigan Cities

Big Rapids - Schedule K-1, Part L, will now check boxes for applicable partner if the following codes are selected: 1 - Tax Basis, 2 - GAAP, 3 - Section 704(b) book and 4 - Other, on the Federal > Common State/City > Generic State Schedule K-1 information > Generic Partner Input > Code 1 field.

Montana

Montana Schedule K-1, Part V, Line 3a automatically calculates for second-tier partnerships and tax exempt entity partners regardless of residency.

Tennessee

Schedule J. Estimates are based on the adjusted business income after the standard deduction on Form 170, Line 33 or Form 174, Line 38.
