Individual

Minnesota

Form M1, Individual Income Tax. The tax calculation for Line 10 was corrected for individuals filing Married Filing Separately with taxable income between \$90,000 - \$92,020.

S Corporation

Missouri

Form MO-1120S, S-Corporation Income Tax Return, Line 1a, will include the addback of all state taxes as required by the instructions.

S Corporation & Partnership

Connecticut

- Connecticut has extended the due date of Form CT-1065/CT-1120SI, Connecticut Composite Income Tax Return, and Form CT-PET, Connecticut Pass-Through Entity Return, to April 15th. Please see the announcement here. Due dates in the return have not been adjusted for this.
- Transmittal Letters will generate for the Connecticut Pass-Through Entity Return.

Missouri

Schedule PTE-BD, Missouri Business Income Deduction, Line 8, will include the Section 179 deduction as expected in the total.

Oklahoma

Form EF-PTE, Pass-Through Entities Income Tax Payment Voucher. Fields have been changed to allow overrides.

Partnership

Connecticut

The underpayment penalty from Form CT-2210PE, Underpayment of Estimated Tax by Pass-Through Entities, will flow to form CT-PET, Connecticut Pass-Through Entity Tax Return, Line 9c.

Montana

- Form PTE, Montana Pass-Through Entity Tax Return, Schedule IV, Part IV, Column F, will equal Column C less the sum of Columns D/E.
- Schedule K-1, Montana Schedule K-1, Part V, Line 3a, is automatically calculated for S Corporation and Partnership owner types.

Estate & Gift

Form 709

- The spouse's name and Social Security Number will print at the top of pages 7 and 9 of the spouse's Form 709.
- The menu was updated to reflect that Page 9 of the spouse's Form 709 is Schedule D.

Form 709, Schedule A. Part 3 of the spouse's Form 709 will state to "See continuation sheet(s)" on the filer's gifts section.

Electronic Filing Updates

S Corporation

Alabama

Extension payments should no longer go to a status of "Missing State Information" and will now process to the taxing authority as expected.

Connecticut

Member information will be included in the electronic file for Form CT-1065/CT-1120SI, Composite Income Tax Return, Part 5 when a Section 179 deduction modification is present. The returns will no longer go to a status of "Schema Validation Error" and will now process to the taxing authority as expected.

S Corporation & Partnership

Minnesota

Schema version was updated to address the Minimum fee update by the state.

Connecticut

Diagnostic has been added for when Form CT-1065/CT-1120SI, Page 5, Part 3 is incomplete/missing required information

Forms CT-1065/CT-1120SI, Page 6, Part 5 member information will now be included in the electronic file when member only has Section 179 deduction (Line 11).

Missouri

Form MO-1120S, Line 1a will include the addback of all state taxes as required by the instructions Form MO PTE-BD, Line 8 will subtract Lines 6 and 7.

West Virginia

Schedule A, Line 10 prints 0 when Form PTE-100APT, Schedule B, Column 3 is 0.

The EPT forms no longer print blank.

Partnership (1065) Product Updates

Diagnostic installed for when Form CT-1065/CT-1120SI, Page 3, Part 1, Schedule C, Line 13 is negative.

Form CT-PET, Line 9c updated to generate from CT-2210PE, Line 6.

Missouri Form PTE-BD, Line 8 is subtracting Line 6 and 7.

Montana

MT PTE Sch IV, Part IV, Column F equals Column C minus Columns D and E.

Sch K-1, Part V, Line 3a is automatically calculating for Partnership and S Corporation owner types.
