Federal

- Form 5405, Line 5, includes the amount of credit repaid on 2012 returns.
- Form 8959, Box 14, code input is available on Expatriate Wages > Wages.
- Form 8960, Line 9b, calculates when filing a resident New York return.

Kansas Electronic Filing

The Kansas Individual eFile extension is not available for Tax Year 2013. Because the Kansas Department of Revenue is not accepting unlinked returns for tax year 2013, they are unable to process individual eFile extensions. If you filed Federal Form 4868 with the IRS for an automatic extension to file, you automatically receive an extension to file your Kansas return. Kansas does not have a separate extension request form. If you are entitled to a refund, an extension is not required.

To pay the tax balance due for an extension, use the Kansas Payment Voucher (K-40 V EXT) and mark the box indicating an extension payment. Mail your Kansas individual income tax return to the following address:

If you do not pay the tax due (may be estimated) by the original due date, you will owe interest and penalty on any balance due.

North Dakota

The amount on Line 2 of the statement for Schedule RZ, Page 3, Line 10, calculates correctly when the return is recalculated.

Philadelphia

Form WTR-Commission, Line 4, Columns A and B, use the correct tax rate for the respective columns.

Virginia

Tax return mailing addresses changed for city/county codes 115, 139, and 730. The first estimate vouchers and the other estimate vouchers changed for city/county codes 115 and 139. Code 139 for Page County street number changed from 101 to 103 S Court St. City code 515 was deleted for all lists.

Partnership (1065) Product Updates

Form 1040C supporting statement now includes credit detail per partner for Form 1040C, Lines 10 and 13.

Oklahoma

Partner level depletion schedules now only print when there is depletion data present in the return.

Pennsylvania - Philadelphia

The calculation of Gross Receipts no longer includes U.S. Interest and Non-Pennsylvania Municipal Bond Interest.

South Carolina

Schedule SC-K, Line 11, no longer doubles the amount of other income from COD deferral.
