New in this Release

Iowa

Improvements placed in service in a 2016 tax year do not conform to the Federal accelerated 15 year life. These assets will default to depreciating over 39 years in any books designed as Iowa.

Note: The 2016 versions of Fixed Assets will only open files last saved in Fixed Assets v2014.01000 or later. Please ensure you have saved all of your existing Fixed Assets client files in the 2014 or 2015 versions before installing the 2016 version.

Conversion Notes

Conversion from Sage[®] Fixed Assets Premier Depreciation is now available. Select **File > Import > Various File Types > Sage Fixed Assets (SQL)** for conversion from Sage[®] Fixed Assets Premier Depreciation.

Note: Sage must be installed to perform the conversion.

Installing CCH ProSystem fx Fixed Assets

Refer to the CCH ProSystem fx Fixed Assets Instruction Guide for complete information on installing and using CCH ProSystem fx Fixed Assets.

Please follow the instructions below to install this release:

Real Time Virus Scan Reminder: The Fixed Assets directory structures must be excluded from the virus scan on workstations and servers for the program to install and/or run properly.

Installation Steps:

1. Download the release image from Software Delivery Manager. You will be asked to Save "Fixed-Assets-2016.02000.exe". It is recommended to save to the default location.
2. Double-click the file **Fixed-Assets-2016.02000.exe** to launch the installation. If setup does not automatically start, please select **Start > Run** and enter `?:\Fixed Assets-2016.02000.exe` (where ? represents the location of the install files) and click **OK**.
3. At the Permission File screen, select one of the permission key options to find your 2016 permission key and click **Next**. The option to download your permission file from the Internet requires a Single Sign-On (SSO) account login.
4. Click **Next** on the *Welcome* screen to display the *Type of Installation* dialog.
5. Select either a **Network** or **Standalone** install.
6. Click **Next** to continue.
7. Select the destination location for the program files. You can accept the default location or browse to a different location.
8. Click **Next** to continue.
9. Select the destination location for the client data. You can accept the default location or browse to a different location.
10. Click **Next** to continue.
11. Select the features you want to install.
12. Click **Next** to continue.
13. Select the desired program group for your CCH ProSystem fx Fixed Assets icon.
14. Click **Next** to continue.
15. Click **Install** to begin the installation.
16. Once the installation is complete, reboot your PC to ensure that all system files are properly initialized.

Note: When installing from a network, you must run `?:\FixedAst\setup` (where ? is your network drive) on each workstation that will run Fixed Assets. The *Type of Installation* defaults to Workstation Setup. Each workstation must be rebooted after workstation setup is complete.
