#### Office Manager

##### Configure Staff > Tax Preparer

Added a field to enter the Oregon preparer ID. This option is similar to the existing New York field.

##### Configure Applications > Tax Preparation

- **Signature Block** - Added a field to enter the Oregon preparer ID.
- **Miscellaneous Options > Reserved for future use 5 field** - Added the ability to print facsimile Form W-2's for federal, state, and city returns for paper-filed returns only. To produce the W-2's enter: W2PRINT.
- **1040 Options** - Removed "Short form option (2017 and prior)" field from the 1040 Options.

## 2019 Electronic Filing Updates

### State 10-Day Rule

Beginning with Tax Year 2018, many state authorities began requiring electronic filing returns to be calculated and submitted within 10 days of the latest software release. Electronically filed returns expired if they did not meet this requirement.

This year the number of states with this requirement increased, and no exceptions were granted. Please refer to the knowledge base articles below for more information on monitoring these returns.

#### Form 1040

The IRS has revised Form 1040 again this year. The draft 2019 Form 1040 reduces the number of new schedules that may need to be filed from six to three. This is accomplished by drawing into the main Form 1040 the information from Schedule 6 and combining the other new schedules. The three draft schedules for the 2019 Form 1040, and what they are used to report, are:

- Schedule 1 - Additional Income and Adjustments to Income (above-the-line deductions) (this schedule is generally unchanged, except for the renumbering of lines)
- Schedule 2 - Additional Taxes (this schedule is the result of combining 2018 Schedules 2 and 4)
- Schedule 3 - Additional Credits and Payments (this schedule is the result of combining 2018 Schedules 3 and 5).

The resulting 2019 Form 1040 is therefore slightly longer. Where the 2018 Form 1040 had only taxpayer information on the first page, the first page of 2019 Form 1040 now includes the reporting and calculation of taxable income, while the second page includes the calculation of tax, including credits.

 **Note:** Form 1040-SR will not be added. The content is identical to Form 1040 with larger font.

#### QBID (Section 199A) - New Forms 8995 and 8995-A

- The IRS has released Form 8995 and Form 8995-A for calculations related to qualified business income and the qualified business income deduction. Although the output has changed, the input remains largely the same.
- Additional input for QBI carryovers is in process.
- Late Tax Year 2018 changes included the addition of detailed and more automated calculations for passthrough QBI deductions, including import/export.

## Form 1040NR

On Nonresident Alien Income Tax Return > Data Relating to Benefits of a U.S. Income Tax Treaty with a Foreign Country, the Country code will auto-fill based on the entry made in the Tax treaty article code.

## Form 461

- Added state calculations of Form 461 for resident and nonresident returns.
- Added ability to identify income as trade or business for Form 461 purposes.

## Form 5471

Late Tax Year 2018 - completed TCJA requirements

  - ◆ The amount entered will not be adjusted.

- Schedule 1 - Additional Income and Adjustments to Income (above-the-line deductions) (this schedule is generally unchanged, except for the renumbering of lines)
- Schedule 2 - Additional Taxes (this schedule is the result of combining 2018 Schedules 2 and 4)
- Schedule 3 - Additional Credits and Payments (this schedule is the result of combining 2018 Schedules 3 and 5).

The resulting 2019 Form 1040 is therefore slightly longer. Where the 2018 Form 1040 had only taxpayer information on the first page, the first page of 2019 Form 1040 now includes the reporting and calculation of taxable income, while the second page includes the calculation of tax, including credits.

 **Note:** Form 1040-SR will not be added. The content is identical to Form 1040 with larger font.
