CBT Credit Forms 300, 301, 302, 304, 305, 306, 311, 312, 313, and 315 have been updated for filers with tax years ending after June 30, 2020.

Form 315, AMA tax credit, which is pertinent only to filers with prior year credit carryover, now uses only the carryover amount reported on the New Jersey Corporation > Other Credits > AMA tax credit box (Interview Form NJ13, Box 54); detail carryover entries are no longer used.

These forms are automatically produced as PDF attachments to the electronic file. If one or more credits are included with returns for years ending through June 30, 2020, a diagnostic will be issued explaining the need and procedure to include an earlier version of the PDF file with the return.

Form CBT-100U, Business Tax Unitary (Combined) Return, is available for computation for tax years ending after June 30, 2020. The return must be electronically filed. At this time electronic filing approval has not been granted, but is expected shortly.
