Federal

Letters and Filing Instructions. Estimate addresses have been updated for AZ, NM, and PA residents.

Other dependents with an EIC code making them valid for earned income credit are now included in the calculation of qualifying children.

Arizona

Amount of Arizona tax paid including surcharge tax flows to state credit for taxes paid forms when applicable.

Hawaii

Charitable contributions are now included in the calculation of Form N-11, Line 23 when the return is not being itemized.

Indiana

The Federal charitable contribution deduction is no longer added back on Form IT-40, Line 2 since it isn't included in Line 1.

Massachusetts

Schedule Y, Line 9c. Unemployment compensation exclusion family size is updated to reflect the correct number of dependents.

North Dakota

Diagnostic 48196 will produce if an invalid/inactive school district code is present.

Ohio - Ohio Cities

Ohio Cities Generic Form R. Updates have been made to include prior year net operating losses on page 3.

Virginia

Virginia child and dependent care expense deduction now uses the increased federal child care credit expense limit.

West Virginia

West Virginia Schedule A, Line 13A (Other Income from Federal) now includes amounts from Federal 1040, Schedule 1, Line 9. Amounts for tuition and fees, charitable contribution if the standard deduction is used, are no longer are included on Schedule A, Line 21A.
