Alabama Electronic Filing

Federal Income Tax Deduction Worksheet produces when any federal amounts are present (even if the deduction is zero) to prevent rejections.

Form IT NRC, Page 1, Line 8 no longer includes Lines 16 and 20 from the Schedule of Adjustments.

Ohio - Ohio Cities

The Indian Hill tax rate has been updated from 0.525% to 0.475%.

PTE estimates will now flow to the appropriate line on CA Form 100S. PTE payments will not be included in the 5806 underpayment of estimated tax calculation.

Kansas

Form K-120S will include estate and trust shareholders on Page 5 when electing to pay tax.

PTET Worksheet produces for Line 9B (Other taxes paid) with less preparer input.

Depreciation adjustments on Form IA 1065, Schedule A, Line 6 for other reductions now report the amounts as positive. Depreciation amounts no longer display on Form IA 1065, Schedule A, Line 15.

Virginia

Form VA 502, Schedule PTET ADJ has been updated to produce on the first calculation.

Form 502PTET, Page 2, Line 1 has been updated to include the deductions from Form 502PTET, Page 1, Line 2.

Form VA 502PTET, Page 2, Line 8 has been updated to only include payments from Virginia.
